3. I acknowledge and understand that my admission to the College is a privilege and not a right that the COLLEGE has the right and the authority to choose the person or individuals that may be admitted as students of the COLLEGE.

4. I acknowledge and understand that the COLLEGE likewise the authority to prescribe rules and regulations governing non-membership of students in fraternity, sorority, or organization in the COLLEGE and that these rules are valid because they are based in the constitutional right of the school to prescribe the condition they may require of any person or individual aspiring to become their student as well as on public policy as follows:

4.1 The general belief that formation of exclusive organizations or groups in the COLLEGE is disruptive of the unit and peace it wishes to foster among members of the school community.

4.2 The general belief that the presence of fraternities, sororities, or organizations not recognized by the COLLEGE has contributed to the violence experienced on campus.

4.3 The general perception that membership in fraternities, sororities, or organizations not recognized by the COLLEGE has developed hardened character among its students that is contrary to the MISSION and VISION of the COLLEGE.

4.4 The general belief that the absence of fraternities, sororities, or organizations not recognized by the COLLEGE helps in broadening of friendship among students and eliminates the divisive effects of exclusive organizations.

5. I recognize and accept that my continued stay in the COLLEGE is subject to my compliance with prescribed discipline policies, rules and regulations especially with my non-membership in fraternities, sororities, or organizations not recognized by the institution.
6. I fully understand and accept that the **COLLEGE can impose sanction of either dismissal or expulsion** on me, after observance of due process, if I would be found having violated the condition to this affidavit as well as having falsely certified any information stated herein, which are both tantamount to failure to maintain a continuing requirement for college admission.
